

PUBLIC PATH DIVERSION ORDER 2022

HIGHWAYS ACT 1980 SECTION 119

THE CAERPHILLY COUNTY BOROUGH COUNCIL PARISH OF RHYDYGWERN PUBLIC BRIDLEWAY NO 49 (PART)

This order is made by Caerphilly County Borough Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the bridleway described in paragraph 1 of this Order and the public it is expedient that the line of the path should be diverted.

The applicant has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

BY THIS ORDER

1. The public right of way over the land situate at Primrose Cottage, Draethen and shown by a bold, continuous, black line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 42 days from the date of confirmation of this Order.
2. There shall at the end of 42 days from the date of confirmation of this Order be a public bridleway over the land situate at Primrose Cottage, Draethen described in Part 2 of the schedule and shown by a bold, broken, black line on the map contained in this Order.

PART 1

Section as indicated on map	DESCRIPTION OF SITE OF EXISTING PATH OR WAY
A-B-C	That part of Bridleway 49 from point 'A' (approximately GR ST 32182 18729) in a South Easterly direction for a distance of 24 metres to point 'B' (approximately GR ST 32184 18727). From point 'B' the bridleway continues in a generally Easterly direction for a distance of 24 metres to point 'C' (approximately GR ST 32186 18727). The route follows the access road from the rear of Primrose cottage to the main Rudry to Draethen road and is recorded as being between 5 to 8 feet in width.

DESCRIPTION OF SITE OF NEW PATH OR WAY

A-D-C A new path commencing at point 'A' (approximately GR ST 32182 18729) and travelling in a South Easterly direction at a width of 1.8 metres along a grassed, earth surface with a metal 'estate' type fence to the East and an embankment to the West for a distance of 35 metres to point 'D' (approximately GR ST 32184 18726). At point 'D' (approximately GR ST 32184 18726), the path turns in a North Easterly direction at a width of 2.0 metres along a grassed, earth surface with the same 'estate' type fencing to the North West, and timber stock fence to the South East for a distance of 23 metres to point 'C' (approximately GR ST 32186 18727).

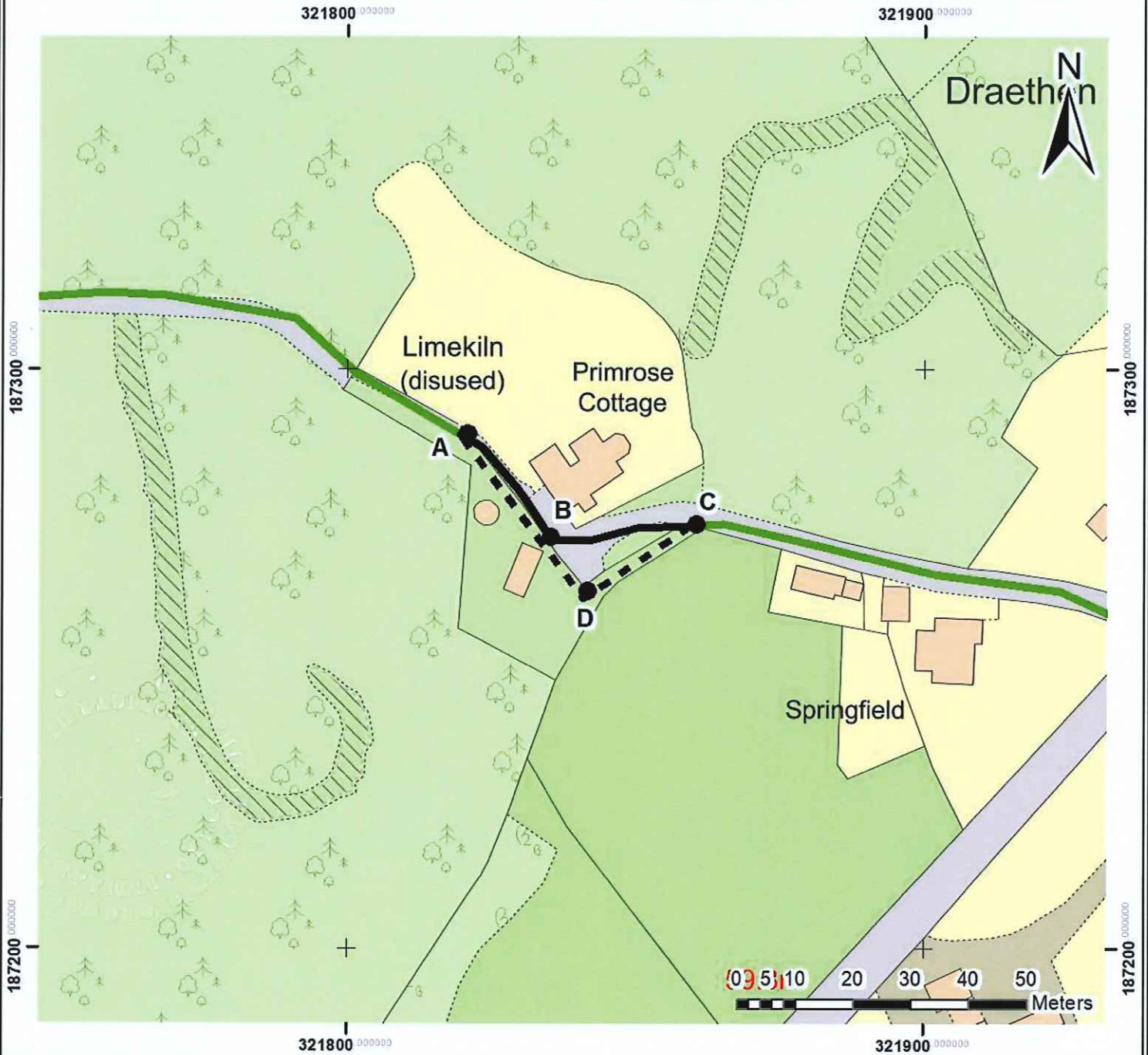
