Introduction and Context

Draethen, Waterloo & Rudry (DWR) Community Council is within the St. James Ward of Caerphilly County Borough. The Community Council represents and serves three rural communities in South-East Wales: Draethen, Waterloo and Rudry and has a population of approximately 1,400 residents. The precept for 2025/26 is £21,000.

DWRCC currently has 7 Community Councillors and employs a part-time Clerk. DWRCC does not currently own or manage any land or buildings.

The communities of Draethen, Waterloo and Rudry sit within a distinctive rural landscape in Caerphilly County Borough, rich in biodiversity and heritage. Habitats such as ancient woodlands, commons and semi-natural grasslands support diverse flora and fauna.

Rudry Common, a 92-hectare Site of Interest for Nature Conservation, provides vital habitats for pollinators, birds and native plants, while surrounding woodlands managed by Natural Resources Wales strengthen ecological connectivity.

The villages also contain Conservation Areas that protect historic character, with features including lime kilns, WWII bunkers and mining relics.

The Ruperra Estate adds further ecological and cultural value, with Coed Craig Ruperra's recovering ancient woodland, an Iron Age hill fort, Ruperra Castle and structures supporting the protected Greater Horseshoe Bat. Community-led conservation continues to enhance both biodiversity and heritage.

Together, these features make Draethen, Waterloo & Rudry a vital part of Caerphilly's green infrastructure, supporting biodiversity, heritage conservation, and community wellbeing.

Review of S6 duty actions for 2023-2025			
What has worked well?	While soil-testing has not yet been completed (scheduled for January 2026), once this is carried out, our verges will be planted with pollinator-friendly species which we hope will enhance local biodiversity. We have also strengthened collaboration with the local authority which enabled dog-fouling to be dealt with promptly and resolved the issue quickly, before any harm was done.		
What have the barriers been?	In the case of the unauthorised tree felling, enforcement action was not possible which reduced our ability to deter harmful practices. While selecting an energy supplier, we considered the biodiversity commitments of each supplier, however, due to being a small customer needing an unmetered supply, most suppliers have refused to supply and therefore, our options are limited.		
What will you change?	We will strengthen consideration of biodiversity in decision-making by carrying out research in advance and providing evidence with practical options, so that our commitments can be more easily built into council decisions.		
How and when will the s6 duty be monitored and the s6 plan reviewed?	We will regularly monitor our section 6 duty. A new biodiversity action plan will be written in 2026. The clerk is already booked onto the Biodiversity Action Plan Webinar with One Voice Wales which will help with writing this.
