1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000 Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the

Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred

under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector. In 2021-22, the Council made payments totalling £

under section 137. These payments are included within

'Other payments' in the Accounting Statement. 2. Staff costs were less this year as Clerk left employment in March 2021 and replacement not found until July 2021. New

- Clerk hours were 7 hours per week as outlined by One Voice Wales assessment of the post. The replacement Clerk only worked until Dec 2021.
- 3. Payments to Council from 3rd Party £3015 as part of a multi partner project for a new Multiplay Activity Slide for Draethen Park. Partners DWRcc, CCBC and Draethen Community Group. Play equipment supplier as per CCBC preferred provider authorised list. Multiplay equipment ordered using Partners & DWR cc Funds. The equipment will be placed on CCBC asset register to be responsible for maintenance and insurances.
- 4. Payments increased in 2021 due to projects coming to fruition in 21/22. Wateroo Defibrillator, Draethen phone box K6 replacements and new defibrillator bought to be placed in Rudry Primary School for the school to take on and maintain going forward.
  - Assets for DWRcc have increased as we added a Defibrillator in Waterloo, replaced the dilapidated phone box in Draethen and moved its location to stop further damage. Procured a fully automated Defibrillator to cater for adult and child patient to be placed in Rudry Primary School for them to take on to maintain and insure. We also added a bespoke bench placed in Rudry Common and a stepover both of which were procured by a project outside of DWRcc but donated to DWRcc These items have been added to the assets register to monitor, maintain and insure.
  - There are items that have been decommissioned in 2021/22 are from due to new logo DWRcc created rendering the Marketing pop up banners to be decommissioned as well as other pictured marketing material previously listed. The dilapidated phonebox in Draethen has been replaced and located in new position to remove any further risk of damage. The Large photocopier was sold and payment received so removed from Assets Register. It was sold as we no longer have premises to accommodate such a large item. This item was previously listed as a debtor on previous Annual Return therefore remained on asset register until Payment made. Now payment satisfied therefore removed as asset
  - The Total income or receipts figure includes a payment from a joint crowd funding with Draethen Community and DWRcc fto raise funds for the Multiplay slide. £3615 was raised by the Community Crowd funding and Paid to DWRcc we than added £3015 plus the VAT and CCBC will pay the balance once the equipment is installed.
